IN 2018, GOODWILL SERVED 6,868 JOB SEEKERS AND HELPED PLACE 1,644 INTO EMPLOYMENT. THE ORGANIZATION ALSO PROVIDED ONGOING SERVICES TO 502 INDIVIDUALS WITH DISABILITIES.
